# 017/13/01 APOLOGIES FOR ABSENCE

Apologies were received from Cllr J Reid, Cllr D Rutter and Cllr G Thompson.

# 018/13/02 DECLARATIONS OF INTERESTS AND GRANT OF ANY DISPENSATIONS

The Committee was reminded of Cllr C Bruce's recurring dispensation as an allotment holder on the Bolam Avenue Site.

# 019/13/03 MINUTES OF THE ALLOTMENT COMMITEE HELD ON THE 3<sup>RD</sup> SEPTEMBER 2013

Councillor J R Potts enquired as to whether there been any progress regarding potential to develop the site at Ninth Avenue. The Assets Officer commented that himself and the Committee Clerk had visited the site and that investigations still at the preliminary stage.

Councillor J R Potts also enquired as to whether there are any updates regarding the Ph.D. student conducting an investigation at the Bolam Avenue allotment site. The Assets Officer, Sean Robinson commented that work is still ongoing and that he will provide an update as and when received.

The Minutes of the meeting of the Allotments Committee held on the 3rd September 2013 were **AGREED** by the Committee and signed by the Chair.

# 020/13/04 MINUTES OF THE MEETING OF MEMBERS OF THE ALLOTMENTS COMMITTEE WITH THE ALLOTMENT HOLDERS ON 3<sup>RD</sup> SEPTEMBER 2013

The Minutes of the Meeting of Members of the Allotments Committee with the Allotment Holders held on the 3<sup>rd</sup> September 2013 were **NOTED** by the Committee.

# 021/13/05 REPORT OF THE ASSETS OFFICER

(Please find the report of the Assets Officer attached)

The Assets Officer provided the brief update in support of his report.

Comments were made regarding issues with the locks of the Bolam

Avenue site, concerns about the accuracy of the allotment waiting list and

the need to revamp the application forms for potential allotment holders to address changing data concerning areas such as age and disability.

The Mayor, Councillor R Parker noted that he was seeking to update the policy to remove those who no longer wish to be involved and provide greater accessibility for those registered disabled.

Regarding the allotment waiting lists, Councillor K Ellis commented that he was seeking an update on an annual basis in order to best manage the list. This was **AGREED** by the Committee.

The Assets Officer also noted that he is still awaiting the paperwork regarding potential developments on the Beatrice Avenue site from Northumberland County Council's legal department.

Regarding the drainage issues at the Newsham Side Club site, the Assets Officer informed those present that a quote had been achieved in order to place 12 m borehole at the site, however was still awaiting a date for this procedure to take place.

Discussion was then held regarding the mechanics of borehole and related plumbing issues.

The Assets Officer commented that regarding the site at 10<sup>th</sup> Avenue that further discussion is to be sought in order to complete the provision of raised beds at the site. It was also therefore noted that, Councillor J Reid is to use his small fund scheme to complete this development. Further discussion was held regarding the situation and Mrs G Newell commented that the allotment holders were still keen to provide support if required and applicable. Councillor R Parker commented that this issue is to be reported back at the next meeting of the Allotments Committee for information. **Action: SR** 

Discussion was then held by the Committee regarding allotment charge increases. Concerns were expressed by Mr P Buckley regarding the increases, however, it was noted that these changes would not be implemented until 15th April 2015.

Councillor K Ellis commented that the rates charged by Blyth Town Council compare favourably to others within Northumberland.

The Assets Officer, Sean Robinson also noted that recently at the allotment officer conference that the average increase across the region was circa 20%, representing on average £10 per annum.

Councillor J R Potts enquired as to whether the proposal is for a £5 increase across the board. Councillor R Parker replied that the proposal was to be unilateral.

Councillor C Bruce enquired as to the progress regarding development of the site at Bolam Avenue in partnership with the Cyrenians. The Assets Officer, Sean Robinson commented that the Cyrenians have sought a quote for the fencing and are to source equipment from their own horticultural department, with the expected start date to be around February/March 2014.

Potential provision of raised beds akin to those proposed the 10<sup>th</sup> Avenue site was also discussed. Mr P Buckley commented that those on the Wensleydale allotment site - would hold no objections to such a development.

Mr P Buckley also enquired regarding toilets on the allotment sites. The Assets Officer commented that funding for facilities may be available via external sources.

Councillor J R Potts discussed the logistics of access and install of the boxing in of the taps at the allotment sites and whether this may incur future expenditure for the Committee.

# 023/13/07 ANY OTHER BUSINESS AND ITEMS FOR URGENT ATTENTION

The Assets Officer sought support from Blyth Town Council and its allotment holders to host the Allotment Officers conference in the forthcoming year. This was **AGREED** by the Committee.

An outline was also provided by the Assets Officer regarding grit bins and the provision within the Town following an enquiry from a residents group. It was noted that a further investigation is to be conducted regarding this issue which is to be addressed at the upcoming meeting of the Finance Committee held on 9 January 2014 in order to guard against the potential snowballing of responsibility.
