106/14/03: MINUTES OF THE PLANNING & DEVELOPMENT COMMITTEE MEETING HELD ON THE 30TH JANUARY 2014.

Councillor J R Potts wished to draw attention to an area which has occurred, arising from the last Minutes concerning planning application 13/03835/COU. It was noted that Blyth Town Council posted a formal objection however this application was dealt with and agreed via an officer delegated decision.

Councillor J R Potts also provided a contextual background, noting that this was a reoccurring theme from meetings of the Northumberland Association of Local Councils.

Councillor G T Knox, proposed that a formal complaint be lodged to Northumberland County Council on the basis of maladministration.

The Committee Clerk also provided an update regarding this item. It was commented that potentially he could approach Liam Hall who had been assisting with planning related concerns.

It was **AGREED** that a formal complaint is to be submitted to Northumberland County Council to the Leader, and the Chair of Planning.

Councillor A Gibbs-Barton wished to comment of the news that the Biomass Development is not to proceed in North Blyth. Councillor A Gibbs-Barton proposed that a representative be asked to provide a presentation to the Committee as the response received via letter and online is not adequate. This was **AGREED** by the Committee. **Action: LF.**

The Minutes of the Planning and Development Committee held on the 30th January 2014 were **AGREED** and signed by the Chair.

108/14/05: PRE - APPLICATION PRESENTATION FROM UK COAL

After delivering the report, Mr P Wood from UK Coal opened up the floor to questions from Councillors, reminded those present that a Public information exercise is to take place at Horton Grange School on Tuesday 18th March 2014 between 4-8pm and Wednesday 19th March 2014 between 4 and 8pm.

Councillor G T Knox commented that he would reserve comments for when the application was to be considered at this Committee, however enquired as to what benefits are envisaged for the Community. Mr P Wood responded that this would allow for closure and also would allow for the land to be developed in the future. It was also commented that it is sought that the majority of transport is hoped to make use of the Ashington, Blyth and Tyne Line.

It was also noted that it would be expected that this site would represent 80 jobs being provided.

Councillor G T Knox also sought assurances that this site would not be used for landfill. Mr P Wood responded that there had been no talks of this use nor was it something being investigated by UK Coal.

Councillor A Gibbs-Barton wished to thank Mr Wood for his presentation and commented that if Councillors are present at the PIE sessions next week that it is solely for gathering of information.

Councillor B W Elliott enquired as to whether these jobs will be new jobs. Mr P Wood responded that it was hoped that there would be a mixture with people from the South East area who are currently working on the site at Ashington, which is coming to close, remaining in employment.

Mr P Wood also commented that the development would also have a Community Trust fund should it receive planning permission which would put an agreed percentage back in to projects in the local area.
