020/13/1: APOLOGIES FOR ABSENCE

The Chair, Councillor G T Knox also stated his belief that raising awareness within Blyth was crucial in order to gauge wider opinion.

Councillor A Gibbs-Barton expressed his concerns regarding the visibility and placement of the tanks.

The potential for arranging a meeting with the applicants was also discussed by the Committee. The Town Clerk (Democratic Services) commented that this could be used as a catalyst in order to discuss wider concerns and future developments.

It was **AGREED** that the Town Clerk (Democratic Services) is to seek contact with the applicant in order to discuss wider concerns and future developments.

5.2 Other applications which have to be considered before the next scheduled meeting of this Committee

There were no further applications considered by the Planning and Development Committee.

025/13/6: THE TOWN CENTRE AND LOCALISM OPPORTUNITIES

6.1 To consider the attached report

The Committee considered the attached report from the Town Clerk (Democratic Services). It was noted that Northumberland County Council may have to carry the cost of this project and that he was awaiting a response from regarding the size of the referenda needed. It was also noted that discussions were ongoing regarding the 'Community Right to Bid'.

It was outlined that the opportunities would allow for the conduction of an audit of planning within the Town.

The Town Clerk (Democratic Services) also sought opinion regarding areas of the Town classified as conservation areas and whether this helped or hindered development in the Town.

It was noted that the Town Clerk (Democratic Services) was seeking to receive grant funding for this project however also outlined potential developments that would make use of funds allocated to the Planning and Development Committee.

The conservation areas in the Town were further discussed and their geographical position within the Town outlined.

The Chair commented that he was keen to seek the maximum grant and noted that further details would be forthcoming after the Town Council is fully aware of what resources are available for the project. The Town Clerk (Democratic Services) noted that the limit was £7,000.

It was **AGREED** that the recommendation from the report was to proceed.

026/13/7: PARKING IN NORTHUMBERLAND

7.1 To note the attached letter from the County Council's Parking Services Manager dated 3 July 2013

The letter from the County Council's Parking Services Manager dated 3rd July 2013 was considered by the Committee.

It was noted by Councillor A Gibbs-Barton that this was already the Town Council's policy.

The Committee discussed wider parking issues in the Town and associated legislative frameworks.

Councillor A Gibbs-Barton outlined issues regarding parking in and around the Harbour and Park area commenting that he was seeking further information regarding how permanent the current parking arrangements in the area were. **Action: SER**

Councillor B W Elliott informed the Committee of issues around the Beach and Ridley Park regarding the management of off-street parking in the area. Councillor B W Elliott also enquired as to whether the Town Council could seek to acquire Section 106 funds allocated for Toucan crossings from the Wellesley site in order to address the car parking issues. The Town Clerk (Democratic Services) noted that it could be raised at meetings with County representatives. **Action: SER**

It was **AGREED** that a report will be considered at a future meeting based on the Committees discussion at this evenings Meeting.

027/13/8: GYPSY ROMA TRAVELLER TRANSIT SITE.

The Town Clerk (Democratic Services) commented that he had received no update regarding the Gypsy, Roma, Traveller transit site.

028/13/9: NEIGHBOURHOOD PLAN

The discussion of the Neighbourhood plan formed part of the discussion under item 6 above.

029/13/10: CENTRAL LINK ROAD

The Committee noted that the County Council had responded as follows:

Further to our recent conversation and in response to your letter dated 30 May 2013, regarding Blyth Central Link Road, I can confirm that the proposal to build a central link road to Blyth is still at a very preliminary stage. £50,000 has been allocated through the Council's Local Transport Plan Programme 2013-14 to consider the issue of traffic congestion on the main routes into Blyth. A potential solution is to construct a new link road. The work planned in this financial year will look at the feasibility of providing a new link road as well as considering other options to reduce congestion on the main routes into Blyth. As work progresses, it is the intention to engage with interested parties for their input. For this reason, it would be useful if the scheme project designer could attend a future Town Council meeting. If you can let me know the dates of planned Town Council meetings at the end of 2013/beginning 2014, I will make arrangements for county council officers to attend. By the end of the year we may be able to report the output from traffic studies currently being commissioned to help inform the option appraisals.

The Town Clerk (Democratic Services) also noted that a meeting is to be arranged with the relevant authorities within Northumberland County Council to discuss traffic issues in the Blyth.

030/13/11: ITEMS FOR INFORMATION AND URGENT MATTERS

Councillor G T Knox enquired as to whether any further information had been generated regarding the perimeter fence at Wensleydale Middle School. The Town Clerk (Democratic Services) commented that he was still conducting investigations and was to chase up this issue. **Action: SER**

The Town Clerk (Democratic Services) also notified the Committee that the Biomass Power Station in North Blyth had been granted planning consent. Councillor A Gibbs-Barton commented that the applicant had been very good at informing Blyth Town Council even though the plant is not situated within the Parish. The Town Clerk (Democratic Services) commented that he hoped that this news would provide a catalyst for further local development and growth.

Councillor B W Elliott enquired regarding the 21 day statutory planning consultation period and the involvement of Blyth Town Council in the wider planning and development system. The Town Clerk (Democratic Services) commented that comments can always be made however as stated that the statutory period is 21 days.

It was further noted that in order for the Committee to abide the statutory period, that the Committee Clerk would circulate a planning list concerning application in Blyth to all Councillors for consideration and response.

It was **AGREED** that the Committee Clerk was to distribute the planning application list weekly to all Councillors for consideration and response.

Councillor A Cartie commented that he had been in contact with Councillor G Thompson who wished to seek clarification regarding housing in the Cottingwood Green area of Newsham. If was confirmed by the Committee that planning consent had been granted by Northumberland County Council and that the Town Council had expressed concerns regarding potential issues of congestion and parking related to the proposed railway station in the area. It was also noted that the applicant for the development was Homes for Northumberland.
