They would also benefit from some kind of 3G pitch, it wouldn't have to be full size maybe just half size with a fence around so that their ball doesn't go out of play. I've had to answer two questions on age and frequency as you have not given an "other" option for people with no children of park age that still want to respond.
- 9.) The section E is right on the side of my garden. The kids have already climbed up my fence and pulled it down twice we're council have had to put new fence up. My 4 year old daughters bedroom is at the back of the house and some kids are out in the park til sometimes 10pm at night
- 10.) Play ground where it isn't the problem, it's been there since day dot, it's the kids leaving the park to go to the shop and running straight out onto brierly road thats the problem. Leave the park where it is and put a fence around the whole grassed area, acts as a bit of a barrier too x

has a lot of broken glass in it, again from drinkers. My husband has pointed out that the wall running alongside the park should be partially removed

The top area you have proposed to move the park to is far to close the the houses and road and also the parh to the cut. It is also used alot for the kkds to play football as they have no where else flat to play. I also feel that the older children park needs to be done up to as there is notjing exciring for them to play with and most the time they spend it in the smaller younger childs park which is quite intimidating for families with younger children. Benefit of picnic benches and parking would be beneficial as peoplel visiting the park ofren oark on axwell drive where i luve rohht opppsite the park which makes getting on and off hour drives very difficult. The park gets very busy in the summer months with over 20 children on the park so safety is paramount. Please dont move the park, think about the pople who actislly use it and see kids plahing on it every day
