Bolam Avenue

Tendering out of the urgent repairs was recommended in principal. A new power supply was proposed subject to Bolam Allotment Association agreeing to finance the installation of a surveillance camera.

Twentieth Avenue

A meeting was to be arranged between committee members and representatives from Homes for Northumberland to discuss renewal of the perimeter fence. Photo's of the site to be undertaken. ACT DW

Newsham

New fencing for the Gas governor station adjacent to plot 56 was discussed. Northern Gas Networks to be contacted to discuss boundaries. ACT DW

Beatrice Avenue

Clearance of spare land at this site for the creation of 3/4 new allotments was proposed to be undertaken.

Delaval

Installation of new water supply.

Laverock

Installation of new water supply. Repair of boundary fence adjacent property is required. Drainage repair and reinstatement of top soil for plot holder discussed subject to a contribution from NCC as their plant had initially caused this damage.

Wensleydale

A New boundary fence and top soil for the provision of new allotments at the front elevation is required once the transfer of land was undertaken from NCC.

Additional Items

A contract for removal of fly tipping was considered and to be put out to tender.

Skip Hire for ensuing year was discussed to enable all sites to utilise this facility.

It was agreed by the committee that all water standpipes should be protected by brick enclosures.

It was further discussed by the committee that containers for all sites would be looked into to facilitate safe storage.

Notice boards to be re-established for all allotment sites.
