4 Reports

4.1 NCC Report

R.W. - weather has been okay, this has allowed the Grass Cutting to slow down and to give a better quality of cut and extra strimming. Cuts have now stopped at the start of cycle 13 due to wet ground. The Poly Tunnels have proved to be a real asset and have enabled Blyth to win a Silver Gilt Award.

K.N. – All councillors should visit the Poly Tunnels.

R.W. – NCC have new equipment and battery strimmer's to help control the weeds, they're also using blue dye and metal brushes on the sweepers. There have been issues with the sweepers, breakdowns and staffing. NCC are looking at a better way to record their monitoring.

J.P. – Household waste and Trade waste at Broadway Circle this to be followed up.

W.R. – Yes, with Enforcement.

R.W. – Seasonal staff have now been finished rather than kept on due to budget.

4.7 **Partnership Service Notes**

BTC contribute towards an additional 6 cuts, this should end up with between 17 to 19 cuts being achieved across all areas during the grass cutting season.

Officers have reviewed the data for the 2020 cutting season and the data for the 2021 cutting season, which has given officers an overview that in those two seasons only the core grass cuts have been achieved in the main. The data does show that some enhanced cuts have been conducted in certain zones.

The current 2022 data indicates it is again likely that only 12/13 core cuts will be achieved by the time we reach October 2022. This also takes into consideration BTC requesting the grass cutting to be suspended for two full weeks to allow strimming and other work to be conducted in the dry conditions.
